ENTRANCE FEE

The Entrance Fee must be paid in full at the time of registration, and is non-refundable once the school year has begun. **Students who are registered by June 10 are eligible for a \$25 per student Entrance Fee discount.** There is no additional discount in Entrance Fees for families that have more than one child enrolled. For students entering late, the charge for the school year will include a prorated portion of the Entrance Fee.

TUITION

The tuition charge is a yearly amount that is spread over a 10-month payment period from August through May, and is due on the 10th of each month. The first of the 10 monthly payments is due on August 10.

***A \$5.00 per month discount will be applied to each student's account whose tuition payment is received or postmarked by the 10th of the month. *** If the 10th falls on a weekend, payments will be accepted through the next regular school day.

The **constituent rate** will be granted to those who are the custodian of the account and are members of one of the constituent churches. Constituent churches include the Centralia, Chehalis, and Winlock Seventh-day Adventist Churches.

The **non-constituent rate** is applied to all others.

The third child enrolled from the same family qualifies for a 25% discount; the fourth child qualifies for a 50% discount.
